**4 - OLD BUSINESS:**

- A. Referred from the Regular Meeting December 12, 2012 - Mr. Gene St. Germain, Fire Chief of Baldwin Volunteer Fire Department writes The Baldwin Volunteer Fire Department is in the process of constructing a new fire station at the former Baldwin Elementary property on Main Street. The new facility is approximately 60% complete.

The department is in need of some additional funding to complete the project. I would like to make a formal request for \$220,000.00. Two hundred thousand of this request would be for concrete driveways from the facility to Main Street and \$20,000 would be to renovate existing classrooms to be used for a training area.

- B. Referred from the Regular Meeting February 27, 2013 - St. Mary Parish Fire District No. 11 Board of Commissioners request \$10,000 from the St. Mary Parish Council for equipment purchases.

The type of equipment that will be purchased will help with firefighter safety while on the scene of fires. They are looking to purchase Radio Communication equipment that will enhance their ability to communicate with St. Mary 911 Dispatch Center and other agencies.

Some of the funds will go toward the purchase of equipment needed to improve their compliance with State and Federal regulations dealing with Incident Command.

- C. Referred from the Regular Meeting April 24, 2013 - Reggie Harrell, Director and Wilmer Lee, Assistant Director of the Save Our Children Mentoring Program has written seeking funding in the amount of \$25,000 to enhance programs offered to juveniles in St. Mary Parish, provide training, educational experience, academic field trips, materials and supplies.

We thank the council for the support previously contributed to Save Our Children Mentoring Program.

- D. Referred from the Regular Meeting August 28, 2013 - St. Mary Community Action Agency has submitted their Pre-Application requesting funds for Program Year 2014. Funding Request \$69, 500.00. (Regular Funds - \$45,500.00 and Elderly Nutrition - \$24,000.00)

- E. Referred from the Regular Meeting September 25, 2013 - St. Mary Parish Registrar of Voters has submitted their 2014 Budget request.
